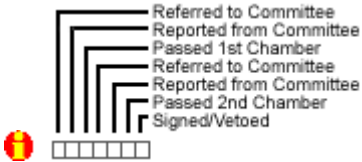

<p>HB 1271 ■</p>	<p>Lant, Bill(R)</p>	<p>Establishes the School Construction Act, which exempts construction and maintenance work done for certain school districts from the prevailing wage requirement upon the school board's approval</p> <p>Last Action: 1-30-18 H Public hearing completed</p>

HB 2177	Brattin, Rick(R)	Requires the State Board of Mediation to conduct an election to certify the exclusive bargaining representatives of an appropriate collective bargaining unit for certain public employees every two years. Last Action: 1-18-18 H Read second time
HB 2215 ■	Brattin, Rick(R)	Exempts state road projects from the prevailing wage law to the extent allowed by federal law. Last Action: 1-31-18 H Referred to House Committee on House-Economic Development
